

NWGYFL Assumption of Risk and Waiver of Liability Relating to

Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact and high contact surfaces. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups and people.

THE NWGYFL and all associated league members have put in place preventative measures to mitigate the spread of COVID-19; however, the NWGYFL and league members **cannot guarantee** that anyone you are legally responsible for or yourself will not become infected with COVID-19 by participating in a NWGYFL sponsored activity or utilization of a league members facility. Further, attending league member or NWGYFL sponsored activities could potentially increase risk of contracting COVID- 19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that those I am legally responsible for and myself may be exposed to or infected by COVID-19 by attending league member or NWGYFL activities or utilization of league member facilities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at league member or NWGYFL activities and utilization of league member facilities may result from the actions, omissions, or negligence of myself and others, including but not limited to NWGYFL volunteers, league member volunteers, and program participants as well as their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to those I am legally responsible for and myself, including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense or any kind, that I or the party I am responsible for may experience or incur in connection with mine or his/her participation in NWGYFL activities or utilization of league member facilities. On my behalf and on behalf of those I am legally responsible for, I hereby release, covenant not to sue, discharge, and hold harmless and indemnify the league member, its employees, agents, representatives and NWGYFL volunteers, of and from any and all claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating there to. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the league member, its employees, agents, representatives and NWGYFL volunteers whether a COVID-19 infection occurs before, during, or after participation in any league member or NWGYFL activity or utilization of a league member facility.

I further agree to take all steps necessary to comply with the Executive and Emergency Orders issued by the World Health Organization (WHO), the Federal Government, the State of Georgia, NWGYFL and the hosting league member.
